# The King's School Charging and Remission Policy

## Overview

This policy tells you when the school may charge for activities for pupils. It tells you when those charges might not apply ('remission'). The policy explains when we may ask for voluntary contributions toward the cost of activities. It also tells you how you can pay charges and contributions.

**The school does not charge for any items associated with the delivery of the core curriculum.**

## The Law

The law says what state-funded schools can and cannot charge for. We cannot charge for activities that take place during the school day (other than break times), but we can ask for voluntary contributions toward the costs. We can charge for optional activities outside of school hours, including lunchtime. We can also charge for board and lodging on residential trips during term time.

## Voluntary Contributions

Voluntary contributions are voluntary. We won't stop any child taking part in an activity because a voluntary contribution has not been paid.

Sometimes an activity costs so much that the school can only afford to run it if most of the people taking part have paid a voluntary contribution. We will make this clear when we invite people to sign up. If not enough people pay the contribution we may have to cancel the activity.

## How to pay

If you can, please use the online system Arbor Pay to pay for activities. We are able to take card payments in school, but if necessary we can accept cash.

Some activities are run by outside companies who ask you to pay them directly. We will always explain how to pay for a particular activity.

## What we charge for

### 1. School lunches

At the moment the government pays for lunches for children in Reception and Years 1 and 2. For the school years 2023-24 and 2024-25 the London Mayoralty is funding school lunches for children in Year 3 and above. If this funding is not renewed we will charge for lunches

If you receive certain state benefits, your child may be entitled to free school lunches whether or not the school is charging. We also offer one free club place per term to children entitled to benefits-related free school meals. Please do contact the office if you think you may be eligible, whatever year group your children are in, as there are other advantages, both for the school and for the family, from having eligibility confirmed.

When payments are in force, we ask parents to commit to, and pay for, school lunches in advance at the start of each half term. We use Arbor to keep track of who has a school lunch, and what has been paid for.

### 2. Breakfast Club

We charge for Breakfast Club. Please pay by Arbor when you book your child into the club for one-off sessions. If your child comes to the club regularly, please pay in advance. Booked sessions must be paid for, even if your child does not attend, unless you tell us the previous day.

At the end of each half-term we will compare sessions used with sessions paid for, and send you an invoice for any money owed. If you have paid for more sessions than you have used, we will carry this forward to the next half term.

### 3. Lunchtime and after-school clubs

We charge for lunchtime and after school clubs. We will tell you how much each club costs at the start of term, when we tell you what clubs are available and when. The charge will be directly related to the cost of providing the club. Children eligible for free school meals may book one free club per term.

You can only book for a whole term, not for individual sessions, and we cannot make refunds if your child misses a session. If the club does not run on a particular day we will try to arrange a catch-up session. If we aren't able to do that we will refund the cost of the session.

For most clubs you can pay via Arbor, but some clubs are run by outside companies that ask for direct payment. Please pay for the club before the first session.

### 4. Independent school references

We charge for providing references to independent schools. We charge £75 for our standard reference, which we will send to all schools that require a reference without further charge. If bespoke references are required for a particular school, including specialist references for particular subjects, we will charge an additional £75 for each different reference.

### 5. Private Assessments for Special Educational Needs

For any families using private professionals to assess their child (for example dyslexia, ADHD or autism, etc.), we charge for completing any forms the private assessors requires. We charge a minimum of £75 for an hour of a teacher's time; if more time is required, it will be charged in

increments of 15 minutes at £15. Payment will be taken before the forms are completed and the school requires a minimum notice period of three weeks to complete these requests. This payment can be made to the school office.

## 6. Breakages and damages

We charge for items of school property that get broken, lost or damaged because of inappropriate behaviour by pupils. We may also charge for deliberate damage to another child's property.

The amount of charge will be decided at the time, but it will not be more than the cost of repair or replacement of the item.

## When we may ask for voluntary contributions

### 1. Educational visits

Visits outside the school can be a valuable part of children's education. If there are costs associated with planned visits, such as entry fees, transport, additional insurance and so on, we will ask parents for a voluntary contribution towards those costs. If you don't pay the contribution your child will still be able to take part in the visit, but if not enough parents pay the contribution we may have to cancel the visit. We do our best to keep costs down, but the school does not receive any funding to cover educational visits.

### 2. School journeys

In years 5 and 6 pupils go on residential trips, with one or more nights spent away from home. We ask for a voluntary contribution to cover the cost of these trips. Because the total cost of a school journey for up to 60 pupils is quite high, unless at least 90% of parents pay the voluntary contribution we may not be able to run the trip. But if a journey goes ahead, no child will be stopped from joining the trip because the voluntary contribution has not been paid.

We use professional school journey companies for these trips, and the companies usually ask for deposits and instalment payments, which are generally non-refundable. The voluntary contributions we ask for will usually match the companies' payment schedule.

### 3. Special events in school

We sometimes arrange for outside providers such as drama companies, artists in residence, cultural specialists, and so on, to come in to school to do activities with pupils. We may ask for a voluntary contribution to cover the costs of some of these events. If you do not pay the contribution, your child will still be able to take part in the activity, but if not enough parents pay the contribution we may have to cancel the event. We do our best to keep costs down **and book free events where available.**

### 4. Materials and ingredients

Some subjects, such as Design and Technology, use a lot of materials and ingredients. To help the school afford this, we may ask for a voluntary contribution towards these costs. If you do not pay the contribution, your child will still be able to take part in the activity. But if you want to keep

something your child has made, we may charge for the materials.

## 5. The Governors' school fund

The governors ask that families contribute to the Governors' School Fund to help bridge the gap between government funding and actual costs.

This is a voluntary contribution, and if you do not pay it will not affect your child in any way.

## Other information

### 1. School milk

Children aged 4 can have free milk each day. Low cost milk is available for older children. If you would like your child to have milk each day please sign up with CoolMilk and pay via their website at <https://www.coolmilk.com/parents/>

### 2. Fruit and vegetable snacks

Children aged from 4 to 6 are given fruit and/or vegetable snacks during the day. This is funded by the Department of Health as part of their effort to encourage children to eat their '5 a day'.

### 3. Richmond Music Trust lessons

Richmond Music Trust offers a range of instrumental lessons for pupils at the school. These are charged for by Richmond Music Trust, not through the school.

### 4. School photographs and show DVDs

We arrange for professional photographers to take school and class photographs each year. We also arrange for professional videographers to film some productions. Parents may purchase photographs and DVDs directly from these providers.

## What if I can't pay?

We want every child to be able to enjoy everything that The King's School has to offer. If it will be hard for you to pay any of the charges mentioned here, please have a private conversation with the Headteacher or the School Business Manager and we will do what we can to help.

If you receive certain state benefits you may not have to pay the charges described in this policy. Please ask at the office if you think this may apply to you.

## Other policies that may apply

- Our **Lettings Policy** gives information about renting parts of the school outside school hours, including what we charge and when the site is available
- Our **Debt Collection Policy** tells you what we will do if you owe the school money for the charges described in this policy
